

TENDER NOTICE

E- Mail tenders on prescribed form are invited from the Registered Contractors for the works enclosed in ANNEXURE No.1. The Tender shall be received by the Block Development Officer(B.P), Kumaratchi or by the authorized Officer up to 3.00 pm on **14.08.2007** and shall be spend on the same day 3.3.0 pm in the presence of Tenderar present. The Tender Schedule form may be obtained against cash payment from the Treasury of Panchayat Union, Kumaratchi on **13.08.2007** before 3.00 pm. The tender deposit amount (EMD) should be in the shape of National Savings Bond at it should have been abstained only on or after 01.04.2007 and the same will be enclosed along with Tender. If the issue of tender schedule date comes on Government Holiday. the tender schedule from shall be issued on the next working day.

CONDITIONS

1. E- Mail Tender should be addressed to the Block Development officer(B.P), Kumaratchi.
2. Name of the Scheme and work should be mentioned on the top of the cover.
3. The EMD of the specified work should be in the shape of national Savings Bond and it should have been obtained only on or after 01.04.2007.
4. The successful Tenderar / Contractor of the work should be produced a agreement on Rs.10/- Bond Paper for the execution of the specified work.
5. The labor welfare fund 0.3%, Income Tax 2%, S.C. on IT 12% shall be deducted from the bill of the successful Contractor.
6. The successful Tenderar / Contractor only allowed to execute the work, sub contract actors shall not be allowed at any circumstances.
7. Income Tax and Sales Tax clearance certificate shall be produced by the successful tenderar / Contractor at the time of work order issued by the authorities concern.
8. If the work is not completed in the specified time 5% penalty shall be levied from the contractor's bill on the estimate amount of the work, then the contract shall be cancelled, the legal action shall be taken against the contractor concern for the loss of work.
9. The Block Development Officer(BP) have the right to change the deposit amount of the tender at any time.

10. The Block Development Officer(B.P) reserves the right to change the date of tender or reject any or all the Tenders with out assigning any reason what so ever.
11. The Technically qualified (Diploma holder) registered contractor of Panchayat Union, Kumaratchi shall be allowed to participate only 0.50 lakhs value of work the B.E. registered contractors shall be allowed only 1.00 lakh value of work.
12. The contractor / Tenderar of water supply work must having sufficient materials and right to execute the water supply / Boer well work and should have been registered as a contractor the Tamil Nadu Water supply Bored.
13. The deposit amount of the contractors and the deductions of caution deposit from the bill shall be issued to the contractors only after completion of the Audit. If any objection raised in the Audit report regarding the Specified work, The fore said Deposit amount of the Contractors shall not be issued.
