1. The earnest money should be deposited by the NSC or by Post Office Term Deposit in value for each work. Which should be Parches on or after **01.04.2007**. The Tender documents shall be issued an payment of corresponding works (Non Refundable) to the Panchayat Union Office Treasury, Kumaratchi.
2. Bid document of works to be done and the set of terms & conditions of contract is consisting of qualifications, drawings, the schedule of qualities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor can be seen in the office of the **Panchayat Union, Kumaratchi on 15.11.2007 up to 4.00 p.m..**
3. The Sale of tender forms on the counter of Panchayat Union, Kumaratchi. The sale of tender form will be stopped on **15.11.2007 (by 4.00 P.M.)**

4. a). Bidding documents must be delivered to Panchayat Union, Kumarachi on **15.11.2007 (by 3.30 P.M. as per Office Clock) on this office working hours.**
 - b). Bids will be opened at **3.30 P.M. as per Office Clock on 16.11.2007** in the Office of Panchayat Union, Kumaratchi. If the Office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
5. Bids must be accompanied by the earnest money deposit of the amount specified for the work in the table. The earnest money will be have to be in any on the forms as specified in the bidding documents. The EMD must be enclosed in the form of NSC or Post Office Term Deposit. Tender without EMD will be summarily rejected.
6. The Bid for the work shall remain open for acceptance for a period of ninety days from the date of opening of bids. If any bidder / Tenderer withdraws his bid / tender before the said period or makes any modificatrion in the terms and conditios of the bid, the said earnest money shall stand forfeited.
7. Eligibility
 - a). The applicant in the same name and style should have achived in any one year a minimum financial turnover (in all cases of Civil Engineering construction works only volume of construction work at least the amount equal to the estimate cost of works (excluding maintenance cost for five years).
 - b). The applicant at least one similar work equal in the value to one third of the estimate cost of work (excluding maintenance cost for five years) or such higher amount as specified.
 - c). The latest / Current income Tax. Sales Tax clearance certificates must be enclosed.
8. No Engineer of Gazetted rank or other employed in Engineer or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor for a period of two years after his retirement form Government Service, without Government permission. This contract is liable to be cancelled if either the Contractor or any of his employees is found any time to be such as person who had not obtained permission of the Government as aforesaid before submission of the tender or engagements in the Contractor's service.
9. The Commissioner, Panchayat Union, Kumaratchi reserves the right to cancel whole or part any tender without assigning any reason thereon.
